RE: Transfer of Appropriations Balances Report – Act 109 of 2020, Section 31(a)

Pursuant to Act 109 of 2020, Section 31(a), below please find attached a report on Transfers of Appropriations Balances approved beyond the \$50,000 amount authorized in the governing statute, 32 V.S.A. § 706. The full text of the governing session law is provided at the end of this memo.

Report:

The report attached is a cumulative list of approved transfers of appropriations balances beyond \$50,000 for FY 2020. It includes ALL the data entered in VISION for that transaction, including:

- Agency/Department name
- Appropriation name and "DeptID"
- Transaction date
- Fund source name and fund number
- Amount
- Comments in response to the question: "Where are funds being transferred to and from?" (VISION allows for a limited number of characters per cell entry.)

Governing Session Law:

Sec. 31. FISCAL YEAR 2020 CLOSE OUT APPROPRIATION TRANSFER AUTHORITY

(a) Notwithstanding 32 V.S.A. § 706, in order to facilitate fiscal year 2020 financial closure of the State, the Commissioner of Finance and Management may, upon approval of the Governor, transfer fiscal year 2020 balances of appropriations up to \$250,000, and, upon approval of the Emergency Board, transfer fiscal year 2020 balances at or over \$250,000 made under any appropriation act for the support of the government from one component of an agency, department, or other unit of the Executive Branch of State government, to any component of the same agency, department, or unit. The Commissioner shall provide a report on all transfers made under the provisions of this subsection to the Joint Fiscal Committee in August 2020.
