Please find attached the report on distribution of the FY 2021 Pay Act.

The FY 2021 Pay Act appropriations were made in Act 120 of 2020 as follows:

Executive Branch

\$11,553,795 General Fund Sec.B.2(a)(1) \$3,911,750 Transportation Fund Sec.B.2(a)(2)

Judicial Branch

\$872,330 General Fund Sec.B.2(b)

Legislative Branch

\$241,000 General Fund Sec.B.2(c)

Of the Executive Pay Act amount described above, \$602,500 is committed to various non-salary items and \$290,120 is committed to other bargained provisions stipulated by the VSEA contract.

Please note, final Executive Pay Act transfers occur near the end of the fiscal year and may differ from transfers listed in the attached schedule based on an assessment of each department's final need. Judicial and Legislative Pay Act transfers occur at the beginning of the fiscal year and typically match the amount appropriated.

Currently, there is a \$2,808,549 balance between the Executive General Fund Pay Act need and the Executive General Fund Pay Act appropriation and a \$1,147,886 balance between the Executive Transportation Fund Pay Act need and the Executive Transportation Fund Pay Act appropriation. These balances are likely due to a variety of factors, the largest being the impact of the 5-21-20 Secretary's Directive Memo entitled "FY Salary Changes for Exempt Employees – Updated June 1, 2020". These balances will be monitored throughout the FY2022 executive budget development process to ascertain whether funds can be used elsewhere in the budget.

Pay Act Calculation Methodology

The methodology used in developing Pay Act potential need is as follows:

- The General and Transportation Fund share of the required Pay Act are derived from the FY 2021 As Passed budget which reflects an estimated annualized June 30, 2020 payroll base. The analysis controlled for changes in General Fund percentages due to additions of Coronavirus Relief Funds in the FY2021 As Passed budget.
- Department Pay Act salary requirements (that is, the value of the FY 2021 salary increases) are comprised of two components this year:

- O A one-time lump sum payment of \$1,400 for eligible employees. This component is calculated using actual payment data from VTHR.; and
- Step increases for an estimated aggregate statewide impact of 1.9%. This component is calculated using position-by-position projections for all employees using the 2021 As Passed budget, which reflects an estimated annualized June 30, 2020 payroll base for departments. The Pay Act potential need is the value of the General and Transportation Fund share of salaries and benefits that are driven by salary (FICA, retirement, life insurance, and LTD).
- The costs of various non-salary contract items and other bargained provisions are stipulated in certain articles of the State-VSEA Bargaining Agreement.
