Grant/Position Requests

Enclosed please find four (4) items that the Joint Fiscal Office has received from the administration. Three limited service positions are associated with these items.

JFO #2651 - Request to establish one (1) limited service position in the Department of Fish and Wildlife. This position will be responsible for updating and maintaining the Department's database of information relating to rare, threatened, and endangered species. This information is used for conservation planning, land acquisitions, environmental regulatory review, and other research. Funding for this position is available through an existing federal grant.

JFO #2652 - Request to establish one (1) limited service position in the Department of Fish and Wildlife. This position will provide perform various duties in service to the Bat Maternity Colony Technical Assistance Program. The program is a response to the impact of White Nose Syndrome on certain bat populations. The position will provide technical assistance, including educating homeowners about the risks and benefits of bat colonies, as well as working with homeowners to exclude bats from their homes. Funding for this position is available through an existing federal grant. [JFO received 11/20/13]

JFO #2653 - \$710,941 grant from the U.S. Dept. of Commerce to the Vermont Department of Public Safety. These funds will be used to support Vermont's participation in the development of a national public safety broadband communications network. In Vermont, this work will consist of planning, developing, and implementing an interoperable wireless network to support the communication needs of first responders and other public safety operations. One (1) limited service position is associated with this request. [JFO received 10/25/13]

JFO #2654 - \$130,000 grant from Salvation Farms, Inc. to the Vermont Department of Corrections. These funds will be used to convert a building at Southeast State Correctional Facility into a food processing facility that will process large volumes donated surplus crops. Inmate labor will process the crops and make the food available to Vermont food banks. Expedited review has been requested. Joint Fiscal Committee members will be contacted by December 10th with a request to waive the balance of the review period and accept this grant.

Dear Mr. Klein;

Here is the requested letter asking for review by the Joint Fiscal Committee of the pending request to accept private funds so that Salvation Farms can move ahead with planning for construction of the Vermont Commodity Program's primary aggregation and processing space at the Southeast State Correctional Facility in time to process produce from the 2014 growing season.

Roughly \$15,000 will be provided to pay for architectural costs and other planning needs for this project, which when completed "will turn an available and underutilized space into a safe and efficient facility ready to receive, wash, pack, store and ship large volumes of diverse surplus Vermont grown crops by the fall of 2014. Surplus crops garnered and processed through the Vermont Commodity Program are made available to feed some of Vermont's most vulnerable populations while providing a positive, vocational work opportunity to those held in our state's custody," according to Salvation Farms.

The timeline for this valuable project, supported by the Department of Corrections and the Administration of Gov. Peter Shumlin, has been delayed pending approvals in the Executive Branch, and I would greatly appreciate anything the committee can do to help amend the timeline.



Dear Mr. Pallito,

Salvation Farms is building the Vermont Commodity Program's primary aggregation and processing space at the Southeast State Correctional Facility (SESCF) in an available building and through engaging the Vermont Offender Work Program. This will create a stable place and workforce for the efficient and cost effective management of large volumes of Vermont's surplus farm foods. In order to increase this program's operational capacity at SESCF we *must* renovate a building at the facility.

An estimated \$15,000 will be provided to the State of Vermont as early as October 15th 2013, to cover architectural costs related to creating build designs and construction bid documents.

An additional \$100,000 will be provided to the State of Vermont by April 1st 2014 to begin construction.

These funds will turn an available and underutilized space into a safe and efficient facility ready to receive, wash, pack, store and ship large volumes of diverse surplus Vermont grown crops by the fall of 2014. Surplus crops garnered and processed through the Vermont Commodity Program are made available to feed some of Vermont's most vulnerable populations while providing a positive, vocational work opportunity to those held in our state's custody.



Organization Description

Salvation Farms' mission is to increase resilience in Vermont's food system through agricultural surplus management. Our mission is achieved by fostering collaborative, cross-sector partnerships that engage and utilize available resources, skills and knowledge to create efficient practices for managing Vermont's farm surplus.

We are driven by three primary goals:

- Reduce food waste on Vermont farms
- Decrease our dependence on food from afar
- Increase citizen appreciation for our state's agricultural heritage and future

Salvation Farms is deeply rooted in the philosophy that farms are, were and always will be our salvation; small, diversified farms are the cornerstones of healthy, wholesome and stable communities and cultures. We believe that the best way to build lasting change is to involve people in the process; this creates ownership and intrinsic value. Through using a common and essential resource, food is an extremely effective tool for social change.

Our History

After a pilot year Salvation Farms was established in 2005 under the fiscal umbrella of the Northeast Organic Farming Association of Vermont to build a replicable model for community-based gleaning. Gleaning is the act of reaping after the harvest, historically done by the poor. As a proof of concept, we were instrumental in instituting the Vermont Foodbank's gleaning program and have advised most gleaning initiatives statewide. Since developing the practice of professional community-based gleaning more than nine years ago, Salvation Farms has assisted with the capture of more than 1 million pounds of Vermont's surplus farm food.

The Opportunity & Our Strategy

We estimate that more than 85% of available farm surplus crops in Vermont go unused annually, close to 2 million pounds. When this fact is coupled with Vermont's 14% food insecurity rate or number of meals served in our schools daily (54,000) or hospitals annually (600,000), it is obvious that Salvation Farms can increase the consumption of healthy, regionally produced foods by our most vulnerable populations through creative, untapped partnerships.

Salvation Farms is committed to the efficient rescue and integration of Vermont's farm surplus into food access points that serve some of our most vulnerable citizens; the young, the sick, the elderly, and the hungry. To achieve this end, we are developing the Vermont Gleaning Collective: a network of programs that actively engage community members in the responsible management of available farm-fresh food resources? This statewide collective will consist of food focused organizations, like the Rutland Area Farm & Food Link and the Intervale Center, which are committed to increasing our states food independence.

Our vision also includes the development of the Vermont Commodity Program. We know from experience that much of the farm surplus currently captured is lost prior to being utilized. We have developed partnerships with the forprofit food sector to help us move large volumes of surplus to sites where we can easily clean and pack raw surplus or create lightly processed frozen products for distribution to institutions that serve Vermont's vulnerable.

AA-1 Salvation Farms

Attached is an AA-1 for a donation from Salvation Farms (SF). A few years ago, the DOC contracted with SF to provide light processing of surplus agricultural products at the SESCF. Over the past two years, SF and the inmates at the SESCF have donated thousands of pounds of food to the local food shelf. This is food that would otherwise have been thrown away.

SF would like to further expand this project by renovating an existing building on the grounds of the SESCF.

These funds are to be used for the design and renovation of a building on the site of the Windsor — Southeast State Correctional Facility (SESCF). BGS estimates the design cost at \$15,000. Preliminary cost of renovation is estimated at \$130,000. Salvation Farms is committed to fund raising and donating funds dedicated to the total cost of the project. DOC will work with BGS to develop the RFP and Contract for renovations. DOC, through BGS, will not commit to a Contract without receiving the total amount of funds estimated needed for the renovation.

If this project proceeds, it will result in a long term, sole source contract with SF. We expect to request funding for this contract in the SFY15 budget.
